Answer

1. Freedom of Religion,

Explanation: The right to choose a religion (or no religion) without interference by the government.

2. The basic rights which are granted to citizens for the holistic growth of the individuals,

Explanation: The Fundamental Rights, embodied in Part III of the Constitution, guarantee civil rights to all Indians, and prevent the State from encroaching on individual liberty while simultaneously placing upon it an obligation to protect the citizens' rights from encroachment by society.

Explanation: Right to Equality is the first fundamental right assured to the people of India. Article 14-18 of the Constitution guarantees this right to every citizen of India.

First, the Constitution states the ideals that form the basis of the kind of country its people aspire to live in. It gives a set of rules and principles that all persons residing in a country can agree upon and also shape the way in which they want their country to be governed.

Second, it determines the nature of a country's political system. It gives the guidelines that govern decision-making in the country.

Third, a Constitution is needed to protect us from ourselves. It guards against taking any decision in haste or whim that might affect the larger interest.
